

Commuting (Inflows) to Major 'Centres of Employment' within Tyne & Wear

Explanatory Note

The following maps show the commuting patterns of workers to the thirteen largest centres of employment in Tyne & Wear. These centres are the Census LSOAs (Lower Super Output Areas) with over 5,000 people employed at the workplaces located in them.

There are three such LSOAs in Gateshead, five in Newcastle upon Tyne, one in South Tyneside and four in Sunderland. There were no LSOAs in North Tyneside which were among the largest centres of employment.

In total, 138,312 people work in these thirteen centres, around 29% of the total employed in Tyne & Wear in 2001.

All maps were produced using, and subsequently exported from, ONS' Commuter View software. Accompanying employment figures were taken from Census 2001 data. Commentary is made by TWRI. For all enquiries, please contact TWRI.

Background:			

The maps in this document were produced using by the Office for National Statistics' product *Commuter View,* which was released by ONS in April 2008. It shows, on simple maps, commuting flows at the 2001 Census and is intended to enable users to investigate local commuting patterns.

Commuter View covers persons aged 16-74 in employment¹ at the time of the Census and shows flows between residence and workplace.

Maps are largely available for:

- Middle Layer Super Output Areas for outward flows (from a single area of residence to each workplace). ['All Workers' outward flows are also available for Lower Layer Super Output Areas]
- Lower Layer Super Output Area for inward flows (from each residence to a single workplace) This document includes maps from this second set of flows.


Commuting (Inflows) to Major 'Centres of Employment' within Tyne & Wear

LSOAs covered by Maps

The Lower Super Output Areas (LSOAs) included in these maps were selected on the basis of employment. The number of workers in each LSOA was calculated using Census 2001 workplace data, available at Output Area (OA), and aggregated to LSOA level.

LSOAs with more than 5,000 workers were selected, producing a total of thirteen LSOAs within Gateshead, Newcastle upon Tyne, South Tyneside and Sunderland. There were no LSOAs within North Tyneside with over 5,000 workers.

The maps in this section show the LSOAs chosen and their location within the District, including notes of any major centres of employment within the LSOA.

Commuting (Inflows) to Major 'Centres of Employment' within Tyne & Wear

Key Findings

The maps of the thirteen largest 'centres of employment' (at LSOA-level) follow this page.

Key findings include:

- > Gateshead largely attracts commuters from within Tyne & Wear, with some flows from southeast Northumberland, Chester-le-Street and Consett
- Newcastle has the widest geographical spread of commuters. In particular, it attracts more commuters from Tynedale than any other district in Tyne & Wear
- > Commuters into South Tyneside are largely self-contained, with no commutes from Newcastle.
- Commutes into Sunderland are again largely self-contained, with the exception of the Nissan motor works. Very few commutes are made from north of the river Tyne.

In Gateshead

- <u>E01008259</u>: The third-largest centre of employment in Tyne & Wear (over 13,000 workers), located on Team Valley, but less than half the number of workers at the largest centre (in Newcastle upon Tyne). Commutes are primarily concentrated in Tyne & Wear, with low flows from southeast Northumberland and surprisingly low flows from South Shields and Sunderland. However, there are still relatively strong flows from within the District, and from Newcastle upon Tyne, Chester-le-Street and Consett.
- <u>E01008262:</u> Commutes [to Metro Centre & Retail Park] are largely made from within Tyne & Wear, although flows from North Tyneside and Sunderland are relatively low. Of those travelling from outside Tyne & Wear, commutes were largely made from south of Gateshead, particularly from the Consett/Stanley area, and from Chester-le-Street.
- <u>E01008166:</u> Commutes [to Gateshead Town Centre] are again largely made from within Tyne & Wear, with slightly more flows from north of the Tyne, which is likely to be due to this LSOA's location on Gateshead Quayside. There were still few commutes from Sunderland. Of those travelling from outside Tyne & Wear, commutes were largely made form Chester-le-Street.

In Newcastle upon Tyne

- <u>E01008440</u>: The largest centre of employment in Tyne & Wear (nearly 27,000 workers) in the Southern City Centre. Commutes into the area were made from a wide geographical spread, including notable commutes from south-east Northumberland, Chester-le-Street, parts of Tynedale and Consett.
- <u>E01008397</u>: The second-largest centre of employment in Tyne & Wear (over 20,000 workers) in the Eastern City Centre. Similar general commuting patterns as those in the largest centre of employment (above) but slightly weaker commutes from Sunderland and South Tyneside.


- <u>E01008321:</u> Very strong flows [to South of Longbenton] from outside Tyne & Wear, particularly within Blyth Valley and Wansbeck. Stronger flows from North Tyneside and from Newcastle. Flows from the south of the Tyne are relatively widely dispersed.
- <u>E01008395:</u> Commutes [to the Western part of the City Centre] are made from across the Tyne & Wear City Region. Those commuting from within Newcastle appear to travel relatively short distances, as few commutes are made from outer LSOAs.
- <u>E01008437:</u> Smaller numbers of commutes [to Elswick] are made from a wide geographical area, particularly form the north. There are still relatively few commutes made from Sunderland, the majority of which are made from the Washington area.

In South Tyneside

<u>E01008667</u>: Commuters [to part of the Tyne Dock, West of South Shields] were *primarily residents of South Tyneside*. Of those who travelled from outside the District, the majority resided in areas located south of the Tyne (including some commutes from Chester-le-Street). There were no commutes made from Newcastle upon Tyne.

In Sunderland


- <u>E01008703:</u> Commuting[to Sunderland City Centre, over 10,000] is largely contained within the District, with some small flows from southern and eastern parts of South Tyneside and northern parts of Easington. There were very few commutes from north of the Tyne, some from Newcastle but none from North Tyneside.
- <u>E01008855</u>: Commutes into the area [North East of Washington] were made from a wide geographical area, particularly given the smaller number of total commuters. This is likely to be the result the Nissan motor works. Commutes into the LSOA were made from as far as Castle Morpeth in the north and Bishop Auckland in the south.
- <u>E01008775:</u> Commuting [to central Sunderland, including Doxford Park] is largely contained within the District. Those who do travel from outside the district come from a fairly wide geographical area relative to the size of the centre of employment, including Gateshead, South Tyneside, Chester-le-Street, Durham and Easington. There were no commutes from north of the Tyne and very few from Gateshead. This was thought to be attributable to the presence of Doxford Park in the LSOA, as there are alternative large retail centres in Gateshead, Newcastle and North Tyneside. The furthest commute came from Spennymoor.
- <u>E01008850:</u> Commuting [to South East of Washington] was primarily from western parts of Sunderland, and especially from Washington, with smaller number of commutes from surrounding districts. There were still no commutes from North Tyneside or West Gateshead, and only very small numbers from Newcastle.





