

CRIME IN TYNE & WEAR


This bulletin provides a summary of police recorded crime in Tyne & Wear from Q1 2010 to Q1 2011.

Police recorded crime figures for 2010/11 continue to show a downward trend, having fallen by 4.3% since the previous year in England & Wales.

Recorded Crime

- Time Series

- In 2010/11 there were 69,585 crimes recorded in Tyne & Wear. This was 6,160 (-8%) less than the previous year.
- Since 2002/03 (adoption of the NCRS²) the rate of total crime in Tyne & Wear has fallen by 67.5 per 1,000 population to 62.2. In England & Wales a fall was also experienced, down by 38.5 per 1,000 population to 75.1.
- The total number of recorded crimes in Tyne & Wear fell from 140,922 to 69,585 between 2002/03 and 2010/11 and in England & Wales from 5,974,960 to 4,150,097 over the same period.




Crimes by Type, Quarter April – June 2011

- The total number of recorded crimes in Tyne & Wear in Q1 (April—June) 2011 was 16,067, 20% lower than in Q1 2009 and 14% lower than in Q1 2010.
- Between Q1 2009 and Q1 2011 the rate per 1,000 population (households Burglary-Dwelling) fell in eight crime types and stayed the same in four crime types (Sexual Offences, Robbery, Drug Offences and Other Offences).


Violent Crime Q1 2010 – Q1 2011

- Violent crime comprises Violence Against the Person (VAP), Sexual Offences and Robbery. VAP covers the whole spectrum of assaults from pushing and shoving, with no physical harm, to murder.
- Comparing Q1 2010 with Q1 2011, VAP fell by 735 (-21.1%), Sexual Offences by 33 (-14.6%) and Robbery by 19 (-15.1%).



Property Crime Q1 2010 - Q1 2011

- Property crime covers the various ways that individuals, households or corporate bodies have their property damaged or are deprived of it by illegal means (or where there is intent to do so).
- Comparing Q1 2010 with Q1 2011, the largest fall in property crime types was for Criminal Damage, the largest percentage fall was for Theft of Vehicles.
